Abstract: The article examines the role and significance of various measures, including those of a military-patriotic nature, in the field of crime prevention. At the same time, as the main object, the problems of the commission of offenses among young people, especially unorganized ones, as well as the issues of their reduction or prevention by various methods and methods are studied. The measures implemented in Uzbekistan in this area, primarily aimed at ensuring their employment and effective spending of time, and tasks for the future, are noted.

One of the main directions of the policy of any democratic state is crime prevention activities, which consists in the implementation of a set of interrelated measures carried out by bodies and institutions directly involved in crime prevention in order to preserve and strengthen law and order, identify, suppress offenses, as well as determine, eliminate the reasons for committing offenses and conditions conducive to them.

Now the younger generation has many opportunities for their spiritual and physical

It is well known that adolescence is one of the most active periods in the life of every person. It often seems to a growing person who feels an influx of physical strength that he can do anything and at this moment is capable of much. However, due to the lack of life experience, ignorance of the laws, as well as most often simply the inability to control oneself and give an account of one's actions can lead to sad consequences.

For example, this category of our citizens committed 1276 crimes in 2020, and in 2019 this figure was 818 crimes [4].

In this context, the opinion of our President is relevant, who more than once noted that "one crime is also a crime" and stressed that "every fact of committing a crime should alert us all". Of course, each person has the right to choose his own path in life, but if it is not correct, then we should not be indifferent.

It seems that the choice is very large, but in fact there are only two principal options. Law-abiding citizens choose a healthy, safe and happy life, and illegitimate citizens choose a life without rules, where the strongest wins, where chaos and anarchy reign. We must understand that the lower the crime rate, the richer the society.
